Registration Form**

Welcome to NCMC / Nantucket School of Music. NCMC / Nantucket School of Music is a non-profit organization offering private and group music lessons. This registration form details our basic policies and fee structures. Students must be registered with tuition paid before classes begin. The summer term rate is based on a week to week basis in a 12-week session beginning the week of June 22<sup>th</sup>, going through to the week of September 1st. It is not required to sign up for the entire summer session to enroll in private lessons. (see right side of form)

<b>Summer Registration Fee: \$15 (per family)</b>	
<b>(12) 30 minute lessons:</b>	<b>\$324</b>
<b>(12) 45 minute lessons:</b>	<b>\$420</b>
<b>(12) 60 minute lessons:</b>	<b>\$540</b>

**Attendance:** Students are expected to be present for all lessons for which they are registered. One makeup lesson is allowed per semester due to illness or family crisis, and instructors will do their best to accommodate these special circumstances. If a student must cancel a lesson, the teacher should be contacted 24 hours in advance, if at all possible.

Students signing up for 4 classes or less will be charged an \$8 accommodation fee per class: \$35/30 min, \$43/45 min, \$53/60 min
